CAMA CORPORATE MEMBERSHIP 2024

The Civil Aviation Medical Association (CAMA) is an organization comprised primarily of medical and aviation professionals dedicated to education and safety in the aerospace/aviation industry. Each year, CAMA holds an Annual Scientific Meeting in late September or early October to update and educate Aviation Medical Examiners (AMEs) and other medical and aviation professionals, both domestic and international, about the most recent findings and research in aerospace medicine. Our annual scientific meeting is also approved for FAA recertification for AMEs and provides continuing medical education credits (CMEs) to those professionals who attend the educational portions of the meeting. We coordinate and cooperate with the FAA in accomplishing these goals each year. In recent years, we have had as many as 150 medical aviation professionals in attendance at our meetings, along with 30 guests, many of whom are also medical or aviation professionals.

As your company's products and services are relevant and pertinent to our membership base interests, you are invited to join CAMA as a Corporate Member. In 2024, Corporate Membership dues are \$550.00 per year. As a Corporate Member of CAMA, your company would be eligible to have an exhibit table during our 3-day Annual Scientific Meeting at no additional cost. The next annual scientific meeting will be September 19-21, 2024, at the Sheraton Jacksonville Hotel in Jacksonville, Florida. The Corporate Membership allows for a medical professional to attend the conference at the CAMA member rate and would include continuing medical education credits (23.0 hours of CME credit in 2023), and FAA AME recertification if applicable. Your company would also be eligible to register up to two of your employees/exhibitors (individuals not seeking CME or FAA credit) at the guest rate for our annual meeting. The Annual Scientific Meeting guest registration includes all meals (except Saturday night which is a free evening), a Thursday field trip and dinner buffet at the Deerwood Castle and Jacksonville Car Club, and our Honors Night Dinner on Friday evening at the host hotel.

Although it is not required, we do encourage our exhibiting Corporate Member exhibitor representative(s) to register for the meeting. If your representative is a registered participant, he/she would have the opportunity to interact and network during meals and other activities with the professionals most likely to use your products and services. Additionally, registered representatives may attend any or all the educational sessions during the meeting at no additional charge. CAMA will provide a table and a power strip for each exhibitor. If you prefer to become a Corporate Member and exhibit only and not have your representative(s) register for the meeting, they will not be allowed to join the group for meals and other activities but would have full access to participants during breaks and before/after meeting sessions at the hotel. Some of our corporate members have elected this option in past years, but most prefer to be able to network full time with the other participants, doctors, and FAA representatives. We will be glad to discuss special circumstances as needed.

Corporate Members are entitled to place a free full color advertisement in the CAMA publication, *The Flight Physician*, on a space available basis. The available space is usually around 1/4 of a page. *The Flight Physician* is published four to six times each year. CAMA Corporate Members are listed in each publication and on our CAMA Web Site (www.civilavmed.com), along with addresses, contact numbers, and web site information.

Corporate Members may also sponsor coffee breaks at the annual scientific meeting with recognition or may sponsor a luncheon at the meeting and use the lunch hour to provide a lecture or information regarding their products and services. The cost of these sponsorships varies according to the location and catering costs at each hotel in which the meeting is held. Coffee sponsorship is also available at CAMA Sunday (an educational lecture series held the Sunday prior to the start of the yearly Aerospace Medical Association (AsMA) annual scientific meeting, which will be held May 5, 2024, at the Hyatt Regency Hotel, Chicago, Illinois. Attendance for CAMA Sunday is around 100 individuals each year.

We are often contacted by CAMA members for referrals, and we do promote our corporate members first when their products or services are appropriate for those referrals. Each edition of the CAMA publication is distributed to around 1200 individuals via email.
